## If you receive an invitation from NJHI to proceed:

3. Complete the **full Request for Information (RFI) by Friday, May 17**. Once you complete the RFI, you will receive \$1,000 to support your group's efforts.

## Who should answer these RFI eligibility questions?

While we value the work of anyone working to improve their communities, we are interested in connecting with groups whose work is **led by** members of the communities they serve and who see their work as community organizing centered on racial equity.

For this work, we are defining community organizing as work done directly with residents in local communities in ways that honor relationship building, shared responsibility, and group action for systems change.

#### What will NJHI do with this information?

The information shared through responses to the RFI will help NJHI align its resources with the needs of community organizing groups.
